before the 27th March 1990, who have completed 45 years of age on the date of notification published for filling up the posts of Professor, Joint Director (Engineering College Stream) and Director of Technical Education as the case may be, are exempted from acquiring Ph. D. Degree for eligibility for the above posts.

Exempted from possessing Ph. D. Degree but they have to acquire Ph. D. Degree within seven years of the appointment to the post of Assistant Professor as stipulated by the All India Council for Technical Education."

Explanatory Note

(This does not form part of the notification, but is intended to indicate its eneral purport.)

As per G.O. (P) No. 6/2003/H.Edn. dated the 24th January, 2003, the Special Rules for the Kerala State Technical Education Segvice (Amendment/Rules), 2003 were issued as S.R.O. No. 235/2003 in Section iv of the Kerala Gazette No. 11 dated the 18th March, 2003. The Subject Committee of the Kerala Legislature in its meeting held on 30-9-2003 have recommended some amendment to be incorporated in the said Rules. Government have now decided to make appointment to the posts of Principal, Professor and Assistant Professor in Government Engineering Colleges by open selection through Staff Selection Committee constituted by State Government from among the Professors/ Assistant Professors/Lecturers respectively of Government Engineering Colleges in the State of Kerala on the basis of merit. Therefore, it is necessary to make suitable changes in the Special Rules for the Kerala Technical Education Service to incorporate the above provisions.

The notification is intended to achieve the above object.
